Almost two months after American media announced a "major breakthrough" in shutting down the Internet during a cyber attack on the country, the victim's federal officials still have no idea who or what actually perpetrated the break-in. While Russia's government is openly suspected by some U.S. officials, it is also still being speculated that North Korea may have been the culprit and that China may have actually sponsored it. Since the attack, the U.S. Defense Department has issued more than \$250 million in counter-cyber-intrusion contracts to firms to protect government and private sector computer networks. With each of those contracts comes the training the companies must receive before they can handle the military's counter-cyber defense needs. If the U.S. military can't figure out who or what is actually behind the cyber attacks, the civilian agencies are really not receiving any government money. Unfortunately, the National Cyber Security Protection Team, which is under the umbrella of the Department of Homeland Security (DHS), had at least two possible signs that something was afoot. The DHS had a major inter-agency meeting and was analyzing the threat to determine who the culprits may be, The Daily Caller News Foundation has learned. And the DHS and the Central Intelligence Agency (CIA) were already working together to study the menace. Back in September, John Dempsey, chief information security officer for the DHS, told TheDCNF, "The big question on my mind is who are the attackers and why are they attacking? We need to figure this out so that we can defend ourselves." The U.S. Cyber Command (USCYBERCOM) has no idea if the hackers that have been disrupting its operations since June 28 are allied nations or private companies. On Oct. 4, the Defense Department quietly renewed the "cyber kill team" contract, which is one of the most powerful cyber-defense efforts in the U.S. arsenal. According to a government source, the Pentagon is using that contract to re-establish the civilian-military working relationship to defend the country against cyber attacks. Given the latest public disclosure, the Pentagon's actions don't exactly make 3da54e8ca3
